Queensland Sport and Recreation Grants

This month we felt it really important to highlight a number of grants that are currently available for Qld sport and recreation clubs. These sorts of opportunities come around only once per year generally and as such we decided to promote them prominently in this month's newsletter.

Following are some significant grants that clubs should have a look at. Obviously we can help you if you are interested and we can guarantee you a far better chance of success than what you can give yourselves:-

Community Sport Clubs Grant Program

Applications Close: Monday 12 November 2012

Brisbane City Council is inviting Brisbane's sport clubs to submit applications for the Community Sport Clubs Grant Program. These grants have been designed to assist clubs in operating more sustainably. The council is encouraging applications for projects that represent long-term, cost effective value, and result in reductions to ongoing club costs or increased income avenues. The Brisbane City Council recognises that community sporting clubs have differing needs and priorities in order to reduce operational costs. The Council is offering three grant categories for community sporting clubs:

- 1. Community facility upgrade: up to \$100,000
- 2. Community facility maintenance: up to \$10,000
- 3. Organisation development: up to \$10,000

The first two categories provide assistance for facility improvements, while the third category offers assistance for organisational development particularly in the area of effective committee management.

Get in the Game

Applications Close: Saturday 1 December 2012

Get Going is a funding program developed by the Queensland Government's Get in the Game initiative to support sport and recreation at the grassroots level. Get Going provides funding to support not-for-profit local sport and recreation organisations for projects that create opportunities for more Queenslanders to become members. The funding is provided for items and activities to assist clubs in attracting new members.

Queensland not-for-profit sport and recreation organisations and not-for-profit community organisations (whose primary objective is sport or recreation) are eligible for funding up to a maximum of \$10 000.

Get Playing

Applications Close: Saturday 1 December 2012

Get Playing aims to assist local sport and recreation organisations with facility development so more Queenslanders are encouraged to become involved in the sport and recreation activity of their choice. The Queensland Government Get Playing initiative is to fund projects for new facility development or upgrade to support participation in sport and recreation activities.

Queensland sport and recreation clubs throughout Queensland are eligible for up to \$100,000 in funding for sport and recreation organisations for facility development.

Another Interesting Partnership

This month we have been approached by a solar company with an innovative proposal. Custom Solar is a rapidly expanding, independently family-owned, Australian company. Their proposal encompassed them contacting Queensland based community, sporting and other non-profit entities to pitch to them to consider putting a solar system in place to reduce electricity costs – something which the Gambling Community Benefit Fund will actually fund! The GCBF provides one-off grants of up to \$35,000 to approved not-for-profit organisations to help them provide community services or activities that benefit the community. Included within the definition of community services is the installation of solar power and solar hot water systems.

So essentially Custom Solar will refer any non profit organisations wanting to install solar and looking to get full funding for the project to us. We will charge the client to prepare their grant and the client should then be in a position to get their solar system installed at no further cost. So basically for a nominal fee of around \$500 depending on the project an

Secrets of a Good Chairperson

In general, the Chairperson of a Committee should have great leadership skills, have vision, be a good communicator and be able to harness and collaborate together divergent views and personalities into one united team. Obviously the chairperson should also have a strong understand of the organisation, its ethos, its services and it's goals and objectives.

Leadership and people skills are more important that organisational knowledge. A great leader can learn more about the organisation where someone really experienced with the organisation might never be able to learn leadership and people skills.

Ideally you would like to find a chairperson who is a good leader of people and process, someone who feels confident in guiding committee members to accomplish the task in a timely manner. The role of committee chair requires extra work, time for communication with staff/volunteers, a willingness to resolve conflicts among members, and a commitment to keep the committee functioning efficiently and effectively.

The following are ideal personal characteristics of a good chair person:-

- Is visible in their demonstration of support and confidence in other committee members;
- Wants to harness the energies of all to form a committed team all pursuing the same goals;
- Is willing to relinquish some of the chair's formal authority if the job requires it; and
- Is more interested in the committee's success than in his or her own feeling of personal importance.

The good chair is one who can work with people, who can stimulate them rather than brow beat them and can help the group use all the abilities and experiences its members possess and new skills that they develop as they work together.

The committee chair is generally responsible for preparing agendas for the meetings, assigning responsibilities to committee members and doing some of the follow-up to make sure assigned work is being done by members. A good chair person is vital to the success of any non profit organisation.

Grants Available this month across Australia

Queensland Access and Inclusion Community Partnership Program

Applications Close: Monday 12 November 2012

Maximum funding: \$50,000

The Access and Inclusion Community Partnership Program provides funds to community organisations, groups and networks under the auspice of a community organisation for projects or services that improve access and inclusion in Brisbane (in particular community led access and inclusion initiatives). The Brisbane City Council recognises that better access and inclusion will benefit all Brisbane residents and visitors. This target group for this funding is but not limited to:-

- people with a disability or long term chronic condition
- people experiencing temporary impairment
- seniors with age-related access concerns
- parents with young children and associated family, friends and carers

Applicants must be a not-for-profit incorporated organisation, or be under the auspices of a not-for-profit incorporated organisation and able to accept legal and financial responsibility for the project or activity.

Every State Perpetual's 2013 Funding Round Opening Soon

Applications Open: Friday 2 November 2012

Applications Close: Friday 14 December 2012

Maximum Grant: \$200,000

Average Grant 2012: \$60,000

Perpetual Philanthropic Services has a history of providing funding to the non profit sector across Australia. They understand the day-to-day challenges faced by charities and non-profit organisations. The Perpetual Philanthropic organisation manages more than 540 charitable trusts and endowments.

Thanks to the generosity of their philanthropic clients, Perpetual distributes more than \$50 million each year on behalf of the charitable trusts that they manage. Non-profit organisations have the opportunity to apply for grants from those trusts through our annual funding rounds.

Charitable trusts and foundations managed by Perpetual distribute grants and funding opportunities to Social Welfare, Health, Medical Research, Conservation and Environment, Education and Arts and Culture. To be eligible for funding from all trusts and foundations that are managed by Perpetual, your organisation must have at least one of the following:

- Australian Taxation Office Tax Concession Charity (TCC) endorsement or;
- Australian Taxation Office Deductible Gift Recipient (DGR) endorsement.

ACT Grant ACT Aboriginal and Torres Strait Islander Cultural Grants Program

A total amount of \$60,000 is available in the 2012-2013 funding round. This program provides funding for projects or activities that celebrate Aboriginal and Torres Strait Islander culture.

This program closes on 30 November 2012

The aim of the Program is to showcase the cultures of Aboriginal and Torres Strait Islander peoples living in the ACT community through the development of innovative projects that contribute to sustainable communities by highlighting and promoting cultural diversity and social harmony.

Any ACT-based community organisation or group that is either incorporated, or in the process of becoming incorporated. If not incorporated, the applicant must be auspiced by an incorporated organisation. All applicant organisations must have satisfactorily acquitted previous grants.

Northern Territory Grant Saluting Their Service Commemorations Grants

Funding up to a maximum of \$4000 is available through this grant.

This grant is provided for projects that preserve our heritage from wars and conflicts and encourage community participation in commemorative events.

Projects must be directly commemorative of Australia's servicemen and women involved in wars, conflicts and peace operations to be eligible for funding under the Saluting Their Service commemorations grants program. Each application is considered on its merits and in accordance with program priorities. Organisations and communities are expected to contribute towards the project, financially and by providing in-kind support.

The following are eligible to apply:-

Community and ex-service organisations

- Local government authorities
- Other bodies such as museums and schools, depending on the project

South Australian Grant Helping Children with Autism

The Australian Government has committed ongoing funding to address the need for services for children with Autism Spectrum Disorder (ASD), their families and carers. All initiatives include support for parents, families, carers and children from Indigenous backgrounds, Culturally and Linguistically Diverse (CALD) backgrounds and those living in rural and remote areas. Following diagnosis, families contact an Autism Advisor in their state or territory who will provide information regarding eligibility, available funding and Early Intervention and other support services. The Department of Health and Ageing (DoHA) has made new Medicare items available for children aged under 13 years (for diagnosis and treatment planning).

To be eligible for the Early Intervention Service children must satisfy each of the eligibility criteria including:-

- Age
- Diagnosis and
- Residential eligibility.

Tasmanian Grant Student Assistance Scheme (STAS)

Funding is provided for with costs of required education items and services. The scheme provides assistance for low-income families towards the cost of levies for students enrolled from kindergarten through to senior secondary level. It is available to students attending a Government or registered Non-Government school or college and those students eligible to pay levies at the Tasmanian Academy or the Tasmanian Polytechnic.

Victorian Grant Emergency Grant: Sporting and Recreational Equipment

This grant provides up to \$2000 per application to provide assistance to local sport and active recreation clubs and organisations to replace essential sports equipment that has been lost or destroyed as a consequence of fire, flood, significant storm event, theft or criminal damage.

While it is the responsibility of organisations to protect themselves against losses, it is recognised that in some circumstances sport and active recreation clubs suffer losses of essential equipment that they are unable to replace. Grants are available towards the replacement cost of essential equipment owned by the club or organisation. Applications can be made at any time up to three months after the loss or damage.

Applications are accepted from local community-based clubs or organisations involved in the delivery of sporting and active recreation opportunities provided that the organisation:

is non-government and not-for profit;

- is affiliated with a recognised State Sporting Association, Outdoor Recreation Association or regional sporting association;
- has satisfactorily completed the reporting requirements of any previous DVC grants;
 and
- has an Australian Business Number (ABN) or provides written advice from the Australian Tax Office that no withholding tax is required from the grant payment.

WA Grant Community Events Grants

Funding of up to \$20,000 per grant is available. Two written quotes are required for items over \$3,000; a written estimate, advertised price, or one written quote for items under \$3,000 (low value, miscellaneous items can be grouped together to \$1,000)

This grant aims to help communities celebrate significant occasions, encourage cultural diversity and bring communities together. Grants are available for a range of various types of events.

Grants are limited to \$20,000 per organisation, for each financial year. An organisation holding a major event drawing high attendance that's run in partnership with a local government, businesses or community organisation may apply for more.

Not-for-profit organisation or a local government authorities are eligible to apply.

NSW Grants The ClubGRANTS Scheme

This grant aims to ensure that larger registered clubs in NSW contribute to the provision of front-line services to their local communities; and to ensure that the disadvantaged in the community are better positioned to benefit from the substantial contributions made by those clubs.

The CDES Scheme is State-wide program, this means that Community groups apply for funding through clubs or their local Committees, all committees have different deadlines

All clubs with over \$1 million in gaming machine revenue participate.
